Registration (2nd date) for 4th semester Examinations 2017-18 for backlog theory subjects under Autonomous system of the students of 2015 admission batch.

The registration (2nd date) of 4th Semester Examinations, 2017 - 18 for B.Tech./MBA/M.TECH/MCA courses for backlog theory subjects under Autonomous system of the students of 2015 admission batch shall be held between 19.03.2018 and 20.03.2018. However, the B.Tech students of 2015 admission batch (list available in the student's counter) cannot register in the subjects in which they were debarred in the 2nd year Summer Quarter Examinations 2016-17. These students need to register in 2nd year Summer Quarter, 2017-18 for each subject in which they were debarred in 2nd Year Summer Quarter Examinations, 2016-17 and need to attend at least 75% classes to make themselves eligible to appear in 2nd year Summer Quarter Examinations, 2017-18.

The registration fee payable by a student for backlog subjects is Rs. (200X + 20), where X is the number of Theory subjects in which a student will register.

Note: Each B.Tech student of 2015 admission batch must note the following with respect to their eligibility for promotion to 5th and 7th semester courses.

- For securing admission in Third Year (5th Semester B.Tech.), a student must successfully complete/pass in each Sessional/Laboratory/Seminar/Project subject and does not have backlogs in more than 3 theory papers of first year by the end of 2nd year.
- For securing admission to Final Year (7th Semester B.Tech.), the student must satisfy the following
- The student must successfully complete/pass in each component/subject of first year course by the end of 3rd year.
- The student must successfully complete/pass in each Sessional/Laboratory/Seminar/Project/Viva Voce subject of 2nd year by the end of 3rd year.
- The student does not have backlogs in more than 3 Theory Papers of 2nd year by the end of 3rd year.

Important: Each B.Tech student of 2015 admission batch carrying backlog in the 1st and 2nd year subjects must register in the backlog subjects and make effort to clear them by the end of this Academic Session failing which they may be debarred from promotion to higher semester. Furthermore, registration in the backlog subjects shall be a precondition for allowing them to register in the regular 6th course.
